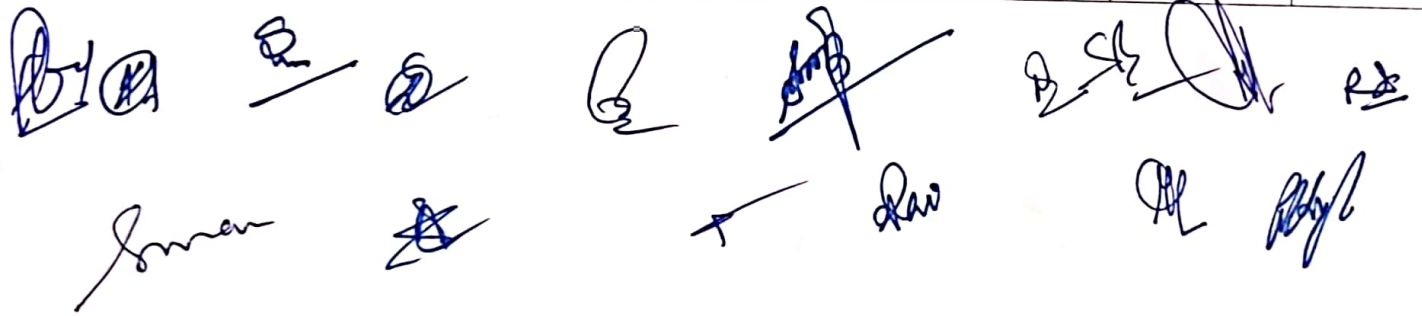

7. **Benevolent Fund: -**

The fund shall be raised in the following manner-

- i. The membership fees of "**U.P. Rural Engineering Services Gazetted Engineer's Benevolent Fund Society**".
- ii. From the interest of the fixed deposits /investment of the fund in Mutual Fund.
- iii. Voluntary donations by the serving or retired Engineers of Rural Engineering Department.
- v. Subscription as a member under any one of two assistance scheme viz. **Chief Assistance scheme (Rs.50000.00)/Principal Assistance scheme (Rs.125000.00) payable in single installment**. Subscription amount in all the two assistance schemes may be enhanced by the approval of the general body.
- vi. Voluntary donations from persons/organizations other than the officers of Rural Engineering Department will be accepted with the prior concurrence of the president or management committee.

8. **General Body: -**

There shall be a General Body which shall consist of following-

- i. All the members shown in Para 6 shall form General body.
- ii. The General Body shall meet once in a year. The notice of the meeting shall be given at least 10 days before the meeting. The quorum of the meeting shall be 2/3rd.

9. **Powers and Duties: -**

- i. To pass annual budget.
- ii. To pass annual report.
- iii. To elect Management Committee.
- iv. **Terms of Managing Committee-Five Years.**
- v. In special circumstances the term of Management Committee will be extended for one more year.
- vi. President will be personally responsible for the formation of new management committee before expiry of Existing Management Committee tenure.
- vii. Outgoing management committee will continue the business of society till the formation of new management committee.
- viii. Registration of Benevolent fund society will be renewed after every five years by the Registrar Society, UP, Vikasdeep Bhavan Charbagh Road Lucknow. Outgoing Management Committee will complete this job before handing over their charge to new Management committee.

10. **Constitution of Management Committee: -**

The benevolent fund shall be administered by-

- i. Management Committee and
- ii. General Body

The office bearer will continue to hold the office till the formation of new Management committee. Office bearers of management committee can only be nominated/elected among the Members of the Society.

- i. The Management Committee will meet at least **twice** a year or as and whenever required at a time and place fixed by the president to adjudicate the claims of benefits and to dispose all business connected with management of the fund. A quorum of meeting is necessary to make its decisions.
- ii. The president may summon a meeting himself or any two members of the committee to deal with any urgent matter and such meeting may exercise all the powers delegated to sub-committee under article 16 mentioned here in after.

whatever the case may be at the minimum rate of interest as decided by the Management Committee. Member shall return back the loan amount in two equal installments within two years.

Membership Amount in the two Assistance scheme can be enhanced and subsequently payable assistance amount can also be enhanced after prior approval of the general body.

15. Duty of General Body: -

It shall be the duty of the General Body to explain to the member engineers of Rural Engineering Department about the society and encourage membership of the fund. The General Body shall obtain nomination forms duly filled in and send the subscription by Net Bank transfer/ UPI/Pay Phone etc. /direct deposit to society account or in the form of demand draft / MICR cheque of any CBS branch/ including the bank charges if applicable, drawn in favour of UP Rural Engineering Service Gazetted Engineers Benevolent Fund Society to Honorary Secretary or Treasurer. 17. Powers of the Office Bearers: -

vii. **Treasurer**

1. To receive subscriptions for the Society from the members and issue receipts.
2. To maintain cash book, Ledger and subscription register and keep them up to-date.
3. To prepare the Income and Expenditure statement at the end of the year.
4. To apprise the President and Honorary Secretary the financial position of the society, whenever asked for.

xiii. **Auditor:** - The annual account of the society will be audited by the Auditor and placed before the Annual Meetings of the management committee which to be held as early as possible after the closing of the financial year.

18. **Revision of Constitution: -**

Any change in the memorandum shall be made only by two third majority of the management committee and subsequently passed in General Body.

19. **Bank Account: -** Accounts will be maintained in one of the Nationalized Banks of India. The President, the Honorary Secretary Jointly with Treasurer of Management committee will operate the Bank accounts by their joint signatures. In case Bank not permit for three signatories in accounts operation then The Honorary Secretary and Treasurer will operate the bank accounts with the written permission by the President in each operation. The Honorary Secretary and Treasurer with the permission of president of management committee may invest the cash at the credit of the fund not required for immediate disbursement in the Nationalized Bank of India.

20. **Withdrawal from Bank: -**

No cash will be withdrawn from Bank in any case. All withdrawal will be through Cheque only. Maximum Cheque withdrawal amount for an individual will not be more than the maximum Assistance Amount for two assistance scheme. However, un limited cheque amount can be withdrawn for the investment in Bank.

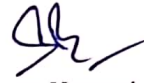

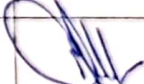
